KEY PROJECT HIGHLIGHTS

Themes

- Child marriage;
- Sexual violence and abuse:
- Commercial Sexual Exploitation of Children; and
- Access to TVET and decent employment opportunities for girls and young women.

Situation of Gender-Based Violence

- Adolescents and young women in particular experience abuses in the form of violence, rape and sexual assault and sexual exploitation, at home, at school and in the workplace.
- Marriage under 18 years has increased particularly high in Western, Central Regions and the 3 Northern regions.

Barriers/Root Causes

- Persistence of adverse cultural norms, practices and traditions
- Patriarchal attitudes and deep-rooted stereotypes regarding the roles and responsibilities of women and men in the family and in society
- Girls and women themselves often lack awareness of their rights and legal literacy (how to claim their rights)
- Very popular cultural belief that women are 'home makers'. Thus, the socialization of females is very different from that of males
- While boys are socialized to fit into the production system, girls are socialized into homemaker roles
- This type of socialization lowers the esteem of girls as compared to their male counterparts, and result in low self-esteem into adulthood

Legislation, policies and the lack of a dequate implementation

- Government has signed up to numerous international human rights treaties, including CEDAW, UNCRC, ACRWC and the relevant ILO conventions
- Current institutional and policy framework on elimination of gender based violence and promoting gender equality:
- Ministry of Gender, Children and Social Protection (MoGCSP);
- Ministry of Tourism;
- Children's Act 1998 (Act 560);
- Human Trafficking Act 2005 (Act 694);

- Domestic Violence Act 2007 (Act 732) and the National Policy and Plan of Action (2009-2019);
- Child and Family Welfare Policy (2014);
- National Gender Policy (2015);
- Justice for Children Policy,
- Tourism Act
- Implementation challenges in real safeguarding of girls and young women:
- MoGCSP lack of resources less than 1% of the national budget
- Lacks capacity a clear mandate for inter-ministerial coordination
- Lack of data
- Inconsistency between formal and customary laws. E.g. Though the Children's Act (Act 560) and other national legislation prohibits child marriages, there is a loop hole;
- ▶ The Islamic law CAP 129 permits marriage for girls under 18 years when she is menstruating and/or when reaching age 16, the age of sexual consent so effectively, CM is permitted by Islamic laws in Ghana. Also, the Marriages Act 1884-1985. the Criminal Offences act (1960). Act 29
- ▶ Access to justice for abused children is impeded as they seldom report abuses
- ▶ No targeted mechanisms to address their peculiar needs by the state
- ▶ Child protection system is too weak to prevent, report and handle cases
- ▶ E.g. Teachers' Code of Conduct to discourage the use of corporal punishment in schools has not been successful due to the absence of monitoring and enforcement mechanisms
- ▶ Weak enforcement of child protection laws, especially on CSEC

Expected Impact

- Girls and young women are free from all forms of gender based violence
- Girls and young women are economically empowered

Strategic Goals

- Increased public support for EE and the elimination of GBV
- Increased influence of CSOs and networks (in particular GYWs organizations) on government and corporate/private sector actors for EE and elimination of GBV
- Multinational, Dutch and national companies increasingly demonstrate a strong commitment for EE and the elimination of GBV

 Governments and regional intergovernmental bodies enforce public policies and programmes for EE and elimination of GBV

Priority Outcomes for 2016-2017

- Mapping and documentation on Child marriage and Sexual Violence and Abuse against children
- Sensitizing and empowering Girls and Young Women on issues of child marriage and Sexual Violence and Abuse
- Engagement of boys and men to be ambassadors of change of negative practices related to child marriage and sexual violence and abuse
- Engaging Key Leaders (Traditional and Religious leaders) and other stakeholders to sensitize them on issues of GBV and abuse, and child marriage
- Building alliance with CSOs
- Strengthening of Inter-ministerial coordination to dialogue on issues on child marriage and sexual violence and abuse to enhance implementation of child protection legislations

- Mapping, Data Collection & Documentation
- Sensitization and capacity building/support
- Lobbying and Advocacy
- Networking and linkages
